Lucianna Colliery has no known maps, but is near Randolph Colliery (bank fire). Review of Western Middle Field mosaics and creation of Eastern Middle Mosaics to follow. Complete Northern Field

Sullivan Co. - Connell B AMDTS is shut down. Connell C AMDTS second pond was drained, but refilled last month. Both are being evaluated by Kleinfelder for redesign. Lewis AMDTS was converted into a limestone drain (compost was removed from top). EPCAMR monitoring and will complete an annual report later this year. Schuylkill Co. - CO2 helps dissolve limestone in the Pine Forest AMD Treatment System buried limestone bed similar in construction to Oneida #1 and Connell B treatment systems.
