## **Project Coordination**

### Swoyersville Harry E. AML Reclamation and Community Athletic Area AMLER Project

 Worked with *Denise Hernandez*, EPCAMR Bookkeeper, on completing the request for reimbursement of August and September's Invoices from Keystone Reclamation Fuels Management for the hauling, excavation, and removal of the waste culm material at the project site; Provided the Progress Report narrative to *Riyad Barkawi*-PA DEP BAMR; Compiled 2022 Invoices for the project with *Denise* to provide to the auditor for testing for the 2022 Single Audit; Received the November 2023 Invoice from Keystone Reclamation Fuels Management for review; Worked on and completed the submission to the PA DEP BAMR for approval and payment

 Provided *Dr. Tammy Shannon*, Penn-State University Environmental Resource Management Program with an example of a service-learning project and course outline that EPCAMR developed with *Dr. Margaria Rose*, King's College to see if any students were interested in future remote service-learning opportunities with rare earth elements and AMD and a list of rare earth elements that EPCAMR knows very little about, in terms of their market value, use, and product potential or commodity

# The Luzerne Foundation Youth Advisory Committee (YAC) 3D Printer on Mines, Macros, and Mining Artifacts Project (*proposed*)

Presented before the Youth Advisory Committee (YAC) of The Luzerne Foundation EPCAMR's proposal to purchase a 3D Printer, supplies, filament, nozzles, design templates, and to allow Staff to spend time working with the Wilkes-Barre Area School District's and Wyoming Seminary's Maslow STEM Programs to create and discuss how to come up with a design to model 3D underground mines using mine maps, create sample mining artifacts and tools, and macroinvertebrates that are found in our streams and waterways; Stroud Water Research Center

already has free design templates for <a href="macroinvertebrates">macroinvertebrates</a>; Other design templates are available for mining tools online; Found out not long after that out of the 18 selected, the YAC could only fund 8, and regrettably, EPCAMR was not able to be funded this round; Mike Shimko from Wilkes-Barre Area's STEM Program followed up after hearing that we were not awarded this round and still would very much like to work with us and produce some of the suggested designs until we can secure funding to obtain our own 3D Printer and he discussed researching handheld scanners that could create 3D images such as items and artifacts in the Lackawanna Coal Mine Tour; <a href="Ed Wytovich">Ed Wytovich</a>, Pioneer Tunnel Board, sent a link to EPCAMR for <a href="Frank Wyso">Frank Wyso</a> to get an idea of objects that could be printed eventually and some things could potentially be sold at the Mine Tours, if allowed; EPCAMR Executive Director connected with <a href="Al Budinsky">Al Budinsky</a> and <a href="Morgan Bratton">Morgan Bratton</a>, <a href="TerraCon">TerraCon</a>, who requested that we submit our proposal to their philanthropic arm of their company, so all grant information was forwarded to Al to provide to his company's Foundation review Committee for consideration in 2024

## **Technical Assistance**

### CWOs and AMR Engagement Project with POWR (proposed)

- EPCAMR Executive Director provided draft comments and a proposal to SRI and WPCAMR for
  consideration to apply for a \$27,700 proposal to engage and survey community watershed
  organizations and Conservation Districts across PA working on abandoned mine reclamation and
  AMD projects; Provided Cliff Denholm, SRI with links to EPCAMR Staff bios, reviewed his final
  budget, and supported its submission by Stream Restoration Inc.; Proposal was submitted on
  December 15<sup>th</sup>; January 8<sup>th</sup> SRI and EPCAMR have a scheduled call with POWR about the
  proposal
- Provided *Jordi Comas*, PA DEP Environmental Justice NC Coordinator with contact information and websites for several community organizations in the EPCAMR region at his request so that he can reach out to them to attend some upcoming informational sessions on climate justice and environmental justice in the coalfields
- Participated in several calls with Arthur Seidenfeld, Rare Earth Metals Reclamation Corporation, New York, to discuss future opportunities in PA and EPCAMR's current work and outreach on the potential for finding critical and rare earth elements in AMD and coal ash from Co-Gen byproducts; Provided Arthur with a brochure on EPCAMR and discussed his company's interest in eventually working in PA
- Provided John Welsh, Rare Light Media, with specific information and history on AMD sites in the
  Lackawanna Valley that he will be visiting with Mark Clement for a video he's producing including
  the Gravity Slope and the Old Forge Borehole; Sent him information, photos, water quality, 3D
  modeling presentation by EPCAMR on the Lackawanna and Wyoming Valley, references to the
  Anthracite Region Remediation Strategy Report from the Susquehanna River Basin Commission,
  information from the Underground Miner's website on the Gravity Slope Colliery, and an article on
  the Lackawanna River fishery
- Forwarded Mike Hewitt the zip file of the water quality lab results from the November 2023 AMD Sampling of a number of sites in the Shamokin Creek watershed
- Provided *Chelsea Tarbell*, PG, <u>HDR</u>, <u>Inc.</u> with contact information for *Chirstine Haldeman* to see if they can provide geophysical work

- EPCAMR Staff participated in a coordinating meeting with the Lackawanna River Conservation Association, PA DEP BAMR, and Kleinfelder, in Scranton to discuss some potential paths forward to take a much closer look at the Old Forge AMD Borehole and the Duryea AMD Outfall and discussed some grant funding opportunities; Finding a way to reduce the flow at Duryea would be a significant accomplishment going forward; Some monitoring needs and mine pool mapping is going to be necessitated at some point now that maps are more readily available than they were a decade ago when EPCAMR first started scanning them for the Commonwealth of PA's Mine Subsidence Insurance Program
- Provided Molly Upgrove, Director of Outreach, Reimagine Appalachia with contacts for various groups, agencies, and non-profits that are involved with youth and STEM programs since they are looking to reach a younger audience to involve in community outreach efforts
- Followed up with Corey Parry, Lehigh Engineering to direct him to the EPCAMR website we
  developed related to solar on previously impacted mine lands since Dan Koury, PA DEP
  Pottsville District Mining Office informed EPCAMR that Reading Anthracite has plans for looking
  at solar development on areas throughout Schuylkill County
- Provided Brother John Paige, CSC, Ph.D., King's College, with EPCAMR contacts with local trail
  and conservation organizations in the Wyoming Valley for his proposed outdoor education
  learning experiences in the Summer 2024
- Followed up with Elizabeth Tate, Associate Partner, with <u>US Practice</u>, who is working with a client that is investing in US renewable energy projects, particularly large-scale solar, hydro, and wind; They are interested in former mining sites and one of their US leaders formerly worked for the Clean Energy Demonstration Program on Current and Former Mine Land (CEML) at the Department of Energy; Convened an introductory call to discuss if there are any mutual interests in exploring future opportunities to collaborate and to provide her with state of these types of projects on abandoned mine lands across PA and some of the challenges and opportunities
- Followed up with *Diana Polson*, Ph.D., Senior Policy Analyst, Keystone Research Center, to provide her with information and have a discussion on abandoned mine lands in Pennsylvania and the influx of federal funds that can lead to opportunities it presents to both clean up environmental damage and create good jobs; She asked for some thoughts and recommendations from EPCAMR on how PA DEP BAMR can help to make the process smoother for nonprofits to apply for grants and how can groups like ours be supported; She asked what kind of data and monitoring needs to be collected or funded
- Provided Judy Rodd, <u>Friends of Blackwater</u>, Thomas, WV, information on AMD issues that PA DOT ran into during the construction of the <u>I-99 Corridor</u> outside of State College since she is expecting to follow some construction activity along a highway within the Blackwater watershed

- Approved final comments suggested by Sara Ramotnik, Choose Clean Water Coalition for the 2024 Legislative Briefing booklet on some considerations that should be given to abandoned mine land issues and AMD issues across the Commonwealth being addressed by EPCAMR's coalition partners, including the Conservation Districts, watershed groups, and other regional non-profit organizations
- EPCAMR was informed that Phil Dunn, has become the Executive Director of the <u>Shamokin</u> Creek Restoration Alliance
- Cathy Tombasco, Black Creek Township, Luzerne County, informed EPCAMR that she has become the new PSU Master Watershed Stewards Program Coordinator for Luzerne/Lackawanna County; EPCAMR provided her with links to information related to AMD, abandoned mine lands, watershed assessment and restoration, and our community partners in the region, that she can pass along to her new cohorts and volunteers in the Program
- EPCAMR convened a Zoom Call for our Education/Science Committee led by our Chair, *Dr. Andrea Nerozzi*, to build on a strategic educational plan going forward for EPCAMR and Staff to guide our ongoing and future educational efforts as funding allows and is sought for various proposed ideas and suggestions; Provided *Dr. Nerozzi* with a few images of the confluence of the Solomon Creek AMD boreholes with the main stem of Solomon Creek in Hanover Township for a poster that her students are preparing of mine outfall microorganisms for the upcoming KCCA Exhibit at Wyoming Seminary
- Received updated information for Carl Rodzewich, Client Manager for <u>Cedarville Engineering</u>, who moved on from Tetra Tech recently; They focus on infrastructure engineering, design build, survey, environmental, grants, and construction projects; Jen Orr-Green is their Environmental Team Lead
