## **Project Coordination**

### Harry E. Breaker Swoyersville Bank Reclamation PA AML Pilot Project

• EPCAMR received the first payment for the project, deposited the check for a \$154,950 into our account, had the EPCAMR President co-sign on the check to be cut to Keystone Reclamation Fuels Management for the initial mobilization work on the site that was invoiced and approved by the PA DEP BAMR for \$150,000 and put it in the mail; Informed Gerard Schmidt-PA DEP BAMR Project Officer that the check was received; Communicated with Matt Cochran-Keystone Reclamation on the project and set up a field visit with Hank Zielinski-Northampton Energy Services, on-site on March 1<sup>st</sup> to walk the site and see how the design and construction of the erosion and sedimentation controls are going as well as to talk about the setting up of an on-site mobile trailer unit with power for the duration of the project; Received a Mining Activity Inspection Report from the PA DEP Pottsville District Mining Office and reviewed it before putting with the project file

#### Mocanagua AMD Mine Pool Consumptive Use Feasibility Study Project

• Entered the Total Ferrous and Total Organic Carbon readings from the lab results that were provided to EPCAMR from Mahaffey Labs, into the Water Quality Database from the January 28<sup>th</sup>, 2019 Sampling event at the Mocanaqua AMD Tunnel discharge; Sampled Mocanaqua on 2-28 for the month; Reviewed Hawk Basin Mine Pool Modeling with Mike; Scheduled a meeting for March 21<sup>st</sup> from 1-3pm at SRBC to go over work on the mapping, modeling, and water monitoring data that has been collected to date to see where we are heading over the next few months of the project

## Growboxx Food by Youth, Reclaiming Our Backyards in the Coalfields

Laura continued to finalize the EPCAMR Reclaiming Our Backyards Education Curriculum and began
ordering the necessary supplies for planting the seedlings and seeds in the Spring and educational
supplies for the 4<sup>th</sup> grade classroom lessons; Laura and Shawnese have found several additional
partners to grow seedlings for EPCAMR for the project

#### Hicks Creek Natural Stream Channel Design/Construction Project

EPCAMR Executive Director reached out to Tammy Nichols-PA DEP Growing Greener Grants Center
to inquire about a termination letter on the project for our file and any further instructions to close out
the grant since all reports and reimbursements have been completed and satisfied

#### Upper Toby Creek Coldwater Conservation Plan Project

 Provided Jessica Britten, EPCAMR Watershed Outreach Education Intern with the field reconnaissance notes and photos from January 8<sup>th</sup>, 2019 for her to organize and insert into a Powerpoint document as Figures for the draft Upper Toby Creek CHP Report; Planning on scheduling a few more field reconnaissance dates with Tom Maykas-DAMA in the watershed in early March with Jessica

## Huntsville Creek Coldwater Conservation Plan Project

EPCAMR was verbally informed that we would be receiving \$4750 to complete the watershed
assessment of the Huntsville Creek tributary of the larger Toby Creek watershed in the Back Mountain
of Luzerne County; EPCAMR had made a revision to the grant budget and removed \$250 for a few
pair of waders at the request of the grant review team and resubmitted the budget for final approval;
An award letter that would be official will be forthcoming this Spring from Ashley Wilmot-Program
Director at PA Council of Trout Unlimited

## **Technical Assistance**

- Informed Melanie Kessler, PA DCED Project Manager that the HBPS would be meeting during the month of February to decide on how they were going to proceed with the remainder of the funds for the project and to apply for an official 1 year extension of the grant; Attended the Huber Breaker Preservation Society's Board Meeting and provided provided Pat Kennedy, HBPS Board Member with several documents for their review during their meeting to develop a response document to PA DCED; Prepared the Extension Letter Request with Ray Clarke, through June 30, 2020 and provided a status update on the project and some future proposed project ideas to utilize the remaining balance in the PA DCED grant and submitted it to Melanie; Forwarded the letter to several HBPS Board members
- Forwarded some thoughts to Mike and Gavin about John Levitsky's idea of coming up with a study or an assessment plan on how can we address losing reaches of headwater tributaries/streams that are actively being lost to the underground mine pool complexes in the region; We may have a better chance at pitching this as a proposal to a foundation than the PA DEP, unless in a future round of Growing Greener, there might be a priority for this type of project in the mining regions that we are serving, possibly even a 319 Grant; This is a discussion worth having with Donna Carnahan, our Project Officer with the PA DEP 319 Program; Dry times, losing reaches of stream; Wet times, gaining reaches of streams and increases or decreases in flows of the AMD discharges targeted are some considerations that he had mentioned; He used Laurel Run in the Wyoming Valley, as an example for such a study; The headwaters are outside of the mining region with little land development and can be used as a control showing water losses and gains attributed to weather in relatively undisturbed forest canopy, forest dormancy/growth comparing evaporation/evapotranspiration; The losses and gains over historical mining areas could then be compared and monitored through strategic mine pool level monitoring; Discussed putting something down on paper and further flushing this idea out with him at some point; Ongoing reclamation, study and proof of the concerns, or tracking which mine pools are affected by what watersheds on the surface or what watersheds are affected by what mine pools are conclusions that we might be able to provide as results; This is something we need to have a follow-up meeting with John on at some point and then see what funding is out there once we have a more concrete plan developed

- Reviewed SRBC-Tom Clark's review of the AMD and water quality sampling that was conducted in
  the Bear Creek tributary watershed of the Wiconisco Creek, Dauphin County; Provided WCRA, DCCD,
  Doc Fritchey Chapter TU, Kerry Teter, and SRBC with links to most of the historic background reports,
  plans, and studies that were completed in the Wiconisco Creek Watershed since 1997, when
  EPCAMR began our involvement in the watershed for historic baseline and background materials;
  Sent Russ Collins-Doc Fritchey Chapter TU a photo of the concrete fabric emergency spillway channel
  for him to use on the intake and outfall sluice way in the Rausch Creek where the diversion wells are
  located
- EPCAMR Staff led the day long Brownfields Training Workshop with the EC on February 1<sup>st</sup> to teach 20 students how to interpret surface and underground mine maps, how to reach topographical maps, how to measure distances, and create simple environmental resource data layers to represent Geographic Information Systems (GIS) that are commonly used in the field; Prepared an Invoice for \$1300 to submit to PSU Wilkes-Barre to cover the EPCAMR Staff costs and professional services for assisting EC with the Introduction to Brownfields Environmental Workforce Training Workshop and Field Tour
- Set up a meeting for March 7<sup>th</sup> to discuss the MS4 AMD Appendix section of the WVSA Permit that they would like some technical professional services work completed for them in the coming year; Reviewed and provided formal comments on the Appendix A to John Pietrzyk, Stormwater Division/GIS Manager in advance of the meeting that the EPCAMR Executive Director, Mike, and Gavin will attend; John provided EPCAMR with a GIS Map of their "sewershed" of the participating municipalities
- Reached out to Heather Cisar-US ACE to discuss AMD remediation planning and water pollution control throughout the EPCAMR Region under the Chesapeake Bay Comprehensive Plan; Haven't heard any response for a few weeks and am only able to contact the US ACE through e-mail
- Rob Dubas, Keep PA Beautiful Program Coordinator followed up with EPCAMR to see how things were coming along with the PA DEP/DCED Indemnification & Hold Harmless Agreement; Informed him that our Board would be looking at it and reviewing it for approval for the security camera installations in Centralia; EPCAMR had one of our Board Attorneys, Dan Taroli, Esquire, review it and provide his opinion on the agreement before we supported it and would sign it; The Board requested that EPCAMR just check with our General Liability Insurance Insurer through POWR before signing and then we could submit it to the PA DEP/DCED with a signature to move forward with the Surveillance Camera Loaner Program through Keep PA Beautiful in the late Spring 2019; Sent the Agreement to Tali MacArthur-PEC POWR to review and she informed me that she had forwarded it to Angela Vitkoski-PEC NE Office, who is more familiar with the POWR General Liability Insurance Policies; Informed Rob of the interest of the Bloomsburg U. MPERS Club to conduct a roadside cleanup that EPCAMR suggested for the Spring; Rob also wanted to see if EPCAMR could ask the Shamokin Creek Restoration Alliance if they were interested in the program as well and taken an active role along Snake Road, where there is also some heavy illegal dumping going on; EPCAMR Executive Director followed up with Jim Koharski, with the watershed group in Northumberland County
- Provided Beth Berkhauser-The Hexagon Project with input on her grant submission to the Lackawanna Valley Heritage Partnership for their annual Hexagon Art Exhibition; She will be rolling out and printing copies of EPCAMR's AMD Art Education Curriculum and Dr. Andrea Nerozzi's artwork at Wyoming Seminary and to compare and contrast the water pollution situation from abandoned mines in China; EPCAMR provided a Letter of Support for the proposal

- Provided Carol Paranzer, Middle Susquehanna Riverkeeper and Fairfax Hutter with some information following a conference call that EPCAMR had provided on the docket as an intervener for the Penn-East Pipeline Project that is proposed to be drilled under the Susquehanna River beneath some of the mining impacted areas within the Wyoming Valley; Forwarded information and Penn-East updates on the project and the proposed trenching across the Susquehanna River to place the 36" gas transmission pipe just a few feet below the alluvial bed of the river to all EPCAMR Staff to inform them of where the project is at in the planning stages and approval process with the FERC; See <a href="shallow\_burial\_depth\_and\_Vortex-induced\_Vibration\_of\_an\_Exposed\_Pipeline">shallow\_burial\_depth\_and\_Vortex-induced\_Vibration\_of\_an\_Exposed\_Pipeline</a> for an interesting read; Forwarded to the EPCAMR Staff previous presentations made by the EPCAMR Executive Director in 2015 to the Gas Drilling Awareness Coalition (GDAC) in the Back Mountain on the cross sections of the Wyoming Valley in the area of the crossing and the underground mining impacts within that region
- Spoke to Joe Mills-Skelly & Loy, Inc. about the Packer 5 AMD Design Project, in the Mahanoy Creek
  watershed, that ended up not being funded under the most recent round of Growing Greener; Talked
  to Joe about expanded the scope of the project in the next round to include some professional
  technical assistance in the mine mapping area from EPCAMR to enhance the proposal

  provided EPCAMR with a copy of the short narrative that was submitted online for our records
  - Donna Morelli-Bay Journal Freelance Writer forwarded EPCAMR a copy of Joint Legislative Air & Water Pollution Control and Conservation Committee February newsletter that contained the Reclaiming Appalachian Coalition's report on abandoned mines entitled, <u>Many Voices, Many Solutions-Innovative Mine Reclamation in Central Appalachia</u> that she thought would be in EPCAMR's interest

- Forwarded two infographics on AML/AMD and watershed restoration statistics to the RECLAIM Field Strategy listserve members who participate regularly on conference calls to discuss the RECLAIM Act
- EPCAMR signed on to the Appropriations Letters going to the Legislature through the Choose Clean Water Coalition

- Followed with Kurt Bauman's NCAC survey on the development of an Executive Director's Forum and
  offered to help facilitate it in any way; The survey was placed in their February Newsletter following our
  discussions at NCAC in late January 2019 after renewing our membership for 2 years
- Informed the EPCAMR Staff that they can access the <u>Patagonia ActionWorks</u> webpage to create events, campaigns, etc. that they will help to amplify through their social media channels, including Facebook; It really helps us to get some organic reaches and new followers, and potentially funders looking at our work through Patagonia partners; Encouraged them to take a look and create their own events and put them up for some of our projects; Created an amplification event for the April 19 Entrance to Ashley Borough Roadside Cleanup
- Provided Laura with some topics and project updates for the March 2019 EPCAMR Newsletter edition
- Forwarded along an RFP for an Outdoor Funding Network Learning Opportunity Grant to several of the EPCAMR Staff working on Environmental Education Projects and Programs that is an opportunity for EPCAMR and a local school district; The Initiative will provide training and up to \$100,000 in direct funding to be distributed over a two-year period for capacity building to establish a local environmental literacy network working to develop an environmental literacy plan and implement a systemic MWEE program; The Chesapeake Bay Trust, in coordination with the Chesapeake Bay Program Education Workgroup, is excited to announce that the Outdoor Learning Network Initiative is now seeking applications; The Outdoor Learning Network Initiative is a funding opportunity for high-need school districts within the Chesapeake Bay region to advance environmental education goals by establishing school district(s) and nonprofit partnerships, receiving capacity building training and ongoing support, and developing and implementing systemic environmental literacy programs using the Meaningful Watershed Educational Experience (MWEE) model; The MWEE is a flexible framework based in the principles of inquiry and project based learning. ## Community Volunteer Coordination

Followed up with EPCAMR Volunteer student from Lehigh University, Cody Benkoski, about creating an example StoryMap in ArcGIS for one of our projects and to begin to gather regional rainfall data for around the Wyoming Valley as a sample of data that we can then correlate to the various flows of AMD throughout the Valley to see what the correlation is between rainfall data and flow discharge and loadings of the various AMD sources to help us better understand the mine pool fluctuations, storage potential, flashiness, or stability and capability of holding stormwater runoff; He has been looking at StoryMaps also; He built a small (proof of concept) Python script to detect the characteristic orange discharges and water-filled stripping pits or ponds of AMD; He has been able to get fairly good detection rates from it in certain circumstances; He requested a collection of Google Maps locations of where AMD is partially visible to see if he could train the model to improve its detection of the AMD; Informed him that we had a GIS layer of AMD points and watershed boundaries on PASDA; <a href="http://www.pasda.psu.edu/uci/SearchResults.aspx?originator=Eastern+Pennsylvania+Coalition+for+Abandoned+Mine+Reclamation">http://www.pasda.psu.edu/uci/SearchResults.aspx?originator=Eastern+Pennsylvania+Coalition+for+Abandoned+Mine+Reclamation</a>

- Followed up with Lauren Perry-student at SUNY-College of Environmental Science and Forestry, NY about coming into the Office on March 11<sup>th</sup> for an interview for a Summer 2019 internship with EPCAMR after having read her cover letter and resume
- Cody Benkoski-Lehigh University student and EPCAMR volunteer provided the EPCAMR Executive Director with rainfall totals from a <a href="www.weather.gov">www.weather.gov</a> endpoint that supplied 24hr totals of rain gauges throughout the Eastern US; He provided two PHP scripts that access and aggregate the data as well as provide a visual way to view the data on Google Maps; He also took a look through the EPCAMR WordPress site and noticed it doesn't seem to be indexed by Google all that well; He suggested looking into getting a WordPress SEO plugin and tag some of the pages/posts; In addition, he thought Host Gator provides free SSL certificates, which will also help our SEO, since SSL is rapidly becoming a necessity on the web; Informed him that EPCAMR would discuss his suggestions over with Mike to see if we can some of those suggested changes

  Cleanup in Centralia this year; EPCAMR informed her that we didn't plan on a Spring Cleanup due to
  not having the funds to coordinate the effort and remove the trash twice a year; EPCAMR suggested
  that they do a roadside cleanup and allow PA DOT to pickup the trash that they might be able to
  collect along the roads throughout the Borough and sign up through Keep PA Beautiful
- Jennifer Deterick, EPCAMR Community Development Coordinator volunteer, provided EPCAMR with
  a list of contacts of corporations within the Hazleton Industrial Park to make inquiries to find out if they
  have any corporate philanthropy we might be able to apply to for funding; EPCAMR Executive Director
  reviewed the list and found some additional contact information necessary to make follow up phone
  calls in the coming weeks ahead
- Followed up with Bill Dructor, BENCO Dental employee, who is interested in becoming an EPCAMR
  volunteer and assisting us with some of our stream and culvert assessments over the late Spring and
