## November 2024 Progress Report EPCAMR Conservation District Mining East Project

### Project Coordination

#### **Swoyersville Harry E. AML Reclamation and Community Athletic Area AMLER Project**

- Attended a Site meeting with PA DEP BAMR, Pottsville DMO, OSMRE, and *Hank Zielinski* to discuss the final grade work being done on the site and a review of the AML and GFCC work now that the 7.5 acres have been transferred and straw has been placed on the site to get grass and vegetative cover on the reclaimed area; Provided *Gerard Schmidt*-Project Officer a sheet on the overages hauled out from the site for the meeting

#### **ARIPPA EPCAMR/WPCAMR AML Mini-Grant Program**

- Cristy Sweeney, ARIPPA, informed both Coalitions, that the ARIPPA Board of Directors approved their 2025 budget that included the continuation of the ARIPPA AMD/AML grant program at the **\$6,000** level; EPCAMR and WPCAMR will therefore each receive **\$3,000** from ARIPPA

#### **Shickshinny Creek/Paddy/Rocky Run Assessment-PA American Water Charitable Foundation**

- Provided *Susan Turcmanovich*, External Affairs Manager for PA American Water, with a copy of the project update that was submitted to the PA American Water Charitable Foundation on the assessment work and the purchase of some of our new field equipment for monitoring; Purchased a used Aqua Calc flow meter and a new HACH Photometer 9800 field testing kit

#### **Shickshinny Creek/Paddy/Rocky Run Assessment-PA TU Coldwater Conservation Plan (proposed)**

- EPCAMR pulled down the application from the PA TU website with *Morgan Romanowski*, AmeriCorps volunteer, to begin the process of applying for a **\$10,000** planning grant; EPCAMR Executive Director will be teaching Morgan the process of applying for this type of planning grant and the budget development process as well as the outreach component on the front end of the application that is needed to gain additional local community support and support of local governments, non-profits, and conservation organizations in the Shickshinny area

#### **EPCAMR/WPCAMR/SRI Survey of Community Watershed Organizations on AMD/AML**

- Reviewed SRI's final reporting to POWR on the project before *Cliff* submitted it

## **Rare Earth Element (REE) Sampling of AMD in the Wyoming Valley with Columbia University**

- *Mike Hewitt*- EPCAMR Program Manager, provided information on Ladwig's research on mine pool stratification in and around the Wyoming Valley to Professor *Sean Kinney*; Forwarded the information to *Morgan Romanowski*, AmeriCorps volunteer who may end up obtaining quarterly borehole monitoring readings once again if we can access them after many years of no funding to be able to get to them and maintain them from being sealed shut; Suggested that we hold off on the depth sampling until Spring 2025 because there is going to need to be maintenance done on existing boreholes just to open them up and free them from dirt and grit from over 12 years of being closed since our last major borehole monitoring project; It takes time to do that; EPCAMR is reaching out to municipalities and Road Departments so that they do not pave over them through our Borehole Awareness Campaign; We have a template letter to go to municipalities that we may need to send again as a reminder to see if they would be willing to help us open some up that need to be daylighted; Forwarded *Sean* and his colleagues a 2024 West Virginia Mine Drainage Task Force Symposium & 15th International Mine Water Association Congress in Morgantown, WV, [article](#), authored by *Elke Mugova*, a colleague of our Executive Director; There are so many other reactions just for iron that take place in the different chemical environments within the mine (oxygen-rich vs. anoxic); We can only imagine there's a multitude of reactions with the critical minerals and rare earth elements; In the Northern Coal Field, there are limestone veins interspersed with the upper coal veins; The Mill Creek Marine Limestone and the smaller Connell Freshwater Limestone Beds are just above the Snake Island Coal bed; There's another freshwater Limestone Bed between the Snake Island and the Abbott veins and lastly the Hillman freshwater Limestone Bed between Kidney and Hillman Coal veins; It's interesting to think that NEPA was often covered by inland seas and even the ocean at different times throughout geologic time; Researched online a monitoring device to collect AMD in the mine pools called a [Bacon bomb sampler](#) and provided the quote to *Sean*, along with a GIS Map of the boreholes we've previously monitored years ago

## **US DOE Capacity Building for Repurposing Energy Assets at the Frackville Morea AML Complex for Floating Solar and Geothermal Potential**

- *Frank Sindaco*, -EPCAMR GIS Watershed Outreach Specialist, made good progress on demographic and land data types along with a social vulnerability analysis for the Morea Mine Complex and surrounding area and continued to work on other infrastructure and transportation systems data; Uploaded Milestone 2 update, PowerPoint update, and Exemplar completion report after working with *Frank*, to the Cohort 2 shared OneDrive and the EnergyWerx portal after having some technical difficulties; Circled back to *Alex Brush*, -Operations Plant Manager for the Gilberton Power Co. to schedule a tour of the Co-Gen Plant across the road from the former Frackville-Morea Co-Gen that is no longer standing and has been dismantled, leaving only the power grid transmission lines and both reclaimed and unreclaimed areas on the land

## **Rare Earth Elements Collaboration with the University of Penn (*proposed*)**

- *John Quigley*, -Senior Fellow for the Kleinmann Center for Energy Policy, requested EPCAMR's participation in a collaborative proposal with [Prof. Jen Wilcox](#), who recently returned to Penn after serving 3 years as Principal Deputy Assistant Secretary for the Office of Fossil Energy and Carbon Management at US DOE; U. Penn is really interested in EPCAMR's help in obtaining representative samples of AMD (especially) and coal waste for testing; In addition, they would welcome our input on the economic revitalization and workforce aspects of the project; *Dr. Wilcox* is developing a proposal to that office in response to a recently released funding opportunity: [Advancing Technology Development for Securing a Domestic Supply of Critical Minerals and Materials](#) – Area of Interest 2: Recovery of Heavy Rare Earth Elements (HREE) from Secondary and Unconventional Resources; EPCAMR Executive Director reviewed the proposal and prepared a Letter of Support for their application following a Zoom call with John on November 15th

## **Sugar Notch Run Trail AML Tire and Watershed Cleanup**

- Continued to remove tires with Staff from the steep hillsides and the areas near the waterfalls along Sugar Notch Run and the abandoned mine openings for safety reasons to get them all to a central location on the upper Sugar Notch Run ridgetop trail and in the drainage swale for easier relocation to the road where they would be picked up and placed into the trucks for proper recycling and disposal; Created a [link](#) on our social media to recruit additional volunteers; Pizza Bella provided us with discounted pizza pies for lunch sponsored by the Wyoming Valley Sanitary Authority (WVSA); **1910** tires (**38,325** pounds) were removed and recycled from the watershed in under **8** hrs by **35** volunteers who participated on November 17<sup>th</sup>; Sent a copy of the sign-in sheets that were filled out by the volunteers to *Megan Finnen*, PA DCNR for the Conservation Volunteer Activity Report and to include them in future invites to cleanups and volunteer activities on State Forest Lands with EPCAMR and PA DCNR

## **Technical Assistance**

- Provided *Keith George*, Luzerne Conservation District with a link to ESRI to see if the District can qualify for discounted ArcGIS Pro licenses for \$100/year/license
- Provided *Bill Eck*-Kingston Township Code and Zoning Enforcement Officer, *Robert Young's* contact information for the PA DEP Office of Energy for him to obtain more information on model solar ordinances for the Township Planning Commission to review
- EPCAMR assisted *Heather Makal*, -Shamokin Creek Restoration Alliance (SCRA) with putting together an interactive Google map for the Shamokin Creek watershed that pins each of the AMD discharges, treatment sites, and borehole locations; *Mike* provided her with a comprehensive list of coordinates of the AMD discharges and of the locations of the 9 AMD discharges that we had sampled over the last year; She is trying to embed the Google map into their website once finished
- Scheduled a meeting with Shamokin Creek Restoration Alliance's Executive Director, *Phil Dunn*, and *Tom Clark*-Kleinfelder to discuss a path forward on some priority areas that SCRA is looking at in the watershed and what type of monitoring or assessment work will need to be proposed for a future grant; SCRA shared a file folder of SCRA Map files created by *Lucas Hower*, student from Penn-State, who completed an AMD Watershed Map for the Shamokin Creek as a part of his class project after having incorporated all the suggestions provide by SRCA and EPCAMR; *Mike* provided *Tom* from Kleinfelder and *Chuck Cravotta*, some georeferenced maps for the Richard's Shaft and Sioux #1 Collieries along Shamokin Creek for review
- *Grace Edinger*, -Procurement Policy Strategy Lead for the Environmental Policy Innovation Center (EPIC) requested on their Draft Findings & Recommendations for PA's AML Program; Provided her with a copy of our presentation from the PA AMR Conference before it was uploaded to the website; Reviewed comments already provided by *Deb Nardone* from the Foundation for PA Watersheds; *Grace* was looking for some sources of information in her draft findings and asked if EPCAMR could provide it or know where to find it
- Provided *Elphas Adam*, a student whom the Executive Director met at the Horizon Conference in Virginia, with several electronic copies of resources to assist him with studying for his drone Part 107 Remote UAS Pilot Certification and suggested that he sign up for the [Pilot Institute Training](#);

Provided all the same materials to *Morgan Romanowski*, AmeriCorps volunteer who is also interesting in obtaining her Part 107 UAS Pilot Certification

- *Louie Krak*, Infrastructure Coordinator, Office of the Governor-Critical Investments, reached out to the Executive Director to thank him for providing comprehensive input on the RISE PA Community Benefits Bonus Guidance; He informed EPCAMR that he has incorporated our feedback and truly appreciated us taking the time to provide thoughtful and constructive comments; EPCAMR has a strong sense of commitment to seeing that we all look at Community Benefit Plans that are holistic, inclusive, innovative, and sustainable that can support the needs of our communities; We work on a watershed level to avoid the political divide of local governments and encourage intergovernmental cooperation and agreements between local governments and community groups to improve the quality of life for all of our citizens in PA
- *Ivie Foster*, [Center County Conservation District](#) Watershed Specialist & Education Coordinator sent the EPCAMR Executive Director a thoughtful response to his mentorship and passion for the work groups like EPCAMR and WPCAMR do with a passion, but also because they are willing to help and guide others, especially those who are early in their careers, who greatly benefit from the training, technical assistance, and networks that EPCAMR provides and helps to coordinate to help her and so many others to learn and grow; She appreciated his positivity and empathy and reminded her that there is always hope for a better and more sustainable future
- Provided *Nick Zmijewski*, Archivist- Industrial Archives & Library with a database in Excel for all of the completed scanned and cataloged Lattimer Mines Mine Map Collection worked on by *Morgan Romanowski*, AmeriCorps volunteer; Nick mentioned that the National Canal Museum has a bunch of mine maps (Lehigh Coal & Navigation) that were taken from the headquarters office in Lansford shortly before the historic fire

### **Luzerne Conservation District AML Grant on State Game Lands 260, Shickshinny (*proposed*)**

- *Derek Herb*, Lab Technician, and Sampler, for Hawk Mountain Labs, provided EPCAMR with a quote for AMD Water Quality Samples, Pickup, and bottles for the expected AMD seep we may sample if the Luzerne Conservation District's proposed project is funded to support sampling and reclamation on State Game Lands 260; Provided *Teah Gray* and *Josh Glace*, -LDG, with a budget for the proposed sampling of the one AMD Seep and other optional budget estimates based on whether or not PA DEP BAMR would conduct the lab sampling and absorb those costs versus having them sampled at Hawk Mountain and collected by EPCAMR for 15 events over the course of a year and doing the appropriate upstream and downstream analysis and sampling to determine load reductions

## **Education & Outreach**

- Participated in the weekly PA AML Campaign calls
- Worked with *Morgan Romanowski*, AmeriCorps volunteer, to develop and update a new EPCAMR tri-fold brochure to be printed for tabling events; Received a quote from Center City Print (CCP) for 100 copies and had them printed; The initial batch of brochures came out fuzzy and pixelated so CCP ran a second batch of printed copies to be picked up in December
- Provided image files of the C-SAW Application for funding and brochure to the full Board of the Pocono NE RC & DC that the Executive Director created to make it easier for partners to post them on social media sites as image files and to websites of the Technical Assistance Service Providers



- *Flora Cardoni*, -Deputy Director for [PennEnvironment](#) requested that I bring up some of her concerns at the Environmental Justice Advisory Board (EJAB) and Joint Citizens Advisory Council (CAC) meeting to underscore the importance of and broad support for a strong state plan for the EPA methane rule that is as ambitious as possible; EPCAMR Executive Director asked the EJAB & CAC several questions related to community health and monitoring; Lisa DePaoli, Center for Coalfield Justice asked a similar line of questions at the meeting
- EPCAMR pushed out the Dashed Virtual Training dates for Stream Restoration Inc. in November on our social media to support their outreach efforts as a partner across the Commonwealth
- *Dr. Andrea Nerozzi*, EPCAMR Board Member and Education Committee Co-Chair provided EPCAMR with a potential new partnership idea with Upward Bound, a 6-week Summer Program at Wilkes University; She will be setting up a conference call or meeting over the Winter with the Director of the Program and EPCAMR to see if there is a collaboration that could be developed to host a Summer field trip for the students; The students also perform community service work
- Assisted the Lackawanna River Conservation Association (LRCA) by clearing last year's seasonal growth of the invasive Japanese knotweed from along the culvert that carries the AMD from the Old Forge Borehole and removed some large woody debris from previous floodwater events; EPCAMR Executive Director, and LRCA's *Tara Jones* and *Bernie McGurl* led a watershed tour with students from the PA DCNR Lackawanna State Park's Community Connections to Our Watershed Program on November 8<sup>th</sup> with *Tony DeSantis*, -Environmental Education Specialist, where they sampled the AMD from the borehole and upstream on the Lackawanna River that was in the lowest flow condition we've seen it in decades; *Tony* sent back a thank you following the educational tour and said that the information that we share is immeasurable
- Completed the Sponsor Verification Report Form for *Mark E. Jones*, Kingston, PA for the AmeriCorps VISTA Community Development Coordinator volunteer position and submitted it to *Shelby Street*-Program Manager for the Stewards Individual Placement Program (SIPP); Informed *Shelby* that EPCAMR will start working on the general Year 2 and Year 3 Volunteer Activity Description Plan and resubmit it to him; EPCAMR signed the Memorandum of Agreement (MOA) for the Energy Communities VISTA Partnership to allow *Mark E. Jones* to start with us following his orientation in early December in Washington DC, with his start date of December 9<sup>th</sup>; Forwarded the MOA to *Hannah Stone*, VISTA Program Director
- Assisted the Earth Conservancy by conducting a few educational programs at the Wyoming Valley West State Street Elementary School on their award-winning We RECLAIM! Environmental Education curriculum and lesson plans on abandoned mine land reclamation and AMD
- EPCAMR Executive Director was featured on a "People of Penn State Podcast" presented by the Penn-State Alumni Association; It was a 60-minute conversational interview with *Paul Clifford*, CEO, of the Penn-State Alumni Association with about a dozen or so questions about his Penn State experience and career/relevant post-Penn State accomplishments; Filled out the Speaker sheet and submitted it ahead of the interview to *Abrielle Clark*, Event Coordinator; Our Executive Director was highly recommended by fellow staff and they all thought he would be a fantastic candidate to share his story and his work with EPCAMR to be a future guest on the series
- EPCAMR signed on to a Letter supporting the continued authorization of the [DOE Clean Energy on Mine Land Program](#), *Rep. McGarvey* (KY) is introducing a bill to extend authorization of the program from 2026 to 2030

- Reached out to *James Pagnotti*, Pagnotti Enterprises, to see if EPCAMR can schedule a meeting with him and *Tom Clark-Kleinfelder* to discuss a novel approach to AMD abatement and treatment of the Old Forge Borehole; *James* would like to set something up after the New Year once he has had a chance to review *Tom's* presentation from the PA AMR Conference; Provided *James* with a copy of *Tom's* revised presentation that was posted to the PA AMR Conference website

### **Keep PA Beautiful Open Your Eyes to Litter (OYEL) Booklet Revisions**

- EPCAMR and KPB reviewed the remainder of the agreement and felt mutually that it needed to be revised; KPB proposed to remove the Spanish translations and Spanish teachers' guide work from us because they have a firm that is doing that for them now and the Project Trash and Science Curriculum; EPCAMR Executive Director let *Laura Rinehimer*-EPCAMR Watershed Outreach Education Specialist know of the revision and provided her with a copy of the revised agreement and remaining tasks to be completed on a few of the other booklets and graphics design to be completed by *Brady Mock*
