# **Project Coordination**

# Upper Toby Creek Coldwater Conservation Plan Project

 Performed culvert assessments and trained several individual volunteers from DHL Logistics, Hanover Township on how EPCAMR conducts the assessments; Signed Kenny Mann and Donald Andress to become Aquatic Organism Protocol (AOP) certified through the NAACC; Conal Herron, former EPCAMR Intern also completed his online certification in AOP

#### Huntsville Creek Coldwater Conservation Plan Project

- Worked with Lauren Perry, EPCAMR Summer Watershed Intern to create a draft powerpoint of the Huntsville Creek CHP Outline
- Coordinated and conducted an electroshocking survey with TU, DAMA, the Luzerne Conservation
  District and The Lands at Hillside in the Huntsville Creek and Brown Creek tributaries to document the
  presence or absence of either brook or brown trout, among other warm water species expected to be
  present below the Huntsville Reservoir; TU will provide EPCAMR with their results following the survey

#### **Wyoming Valley Sanitary Authority MS4 Efforts**

- Reviewed the letter to the Wilkes-Barre Area School District regarding obtaining permission to access and conduct the cleanup along Spring Run that flows through the parcel and to remove any trash from the property on November 2, 2019 from 9-1
- Provided Ms. Schraeder, 8th Grade Science Teacher at Greater Nanticoke Area, a letter of support for her grant to the Educators of America Micro-Grant and assisted her with the preparation of the grant through a Google document by providing her with links to related resources that could be utilized in the classroom on the historical impacts and more recent reclamation efforts in the Nanticoke and Newport Creek watersheds; The grant is requesting water testing equipment that will be a part of the Trout in the Classroom Program and for testing the streams within the Nanticoke School District that are impacted by AMD
- John Whittaker, Scranton, PA ordered some of EPCAMR's iron oxide
- The PA Fish & Boat Commission's Executive Director, Tim Schaeffer, forwarded EPCAMR an updated Lost Recreational Value Excel File based on the 2018 Integrated Non-Attaining List of AMD Impacted Waterways that shows that PA loses \$145.8M in revenue from not being able to utilize AMD impacted streams
- Provided Tali MacArthur, Program Manager for PEC/POWR contact information for the Catawissa Creek Restoration Association at her request
- Provided a letter of support from EPCAMR to Dr. Melanie Shepard, Ph.D., Misericordia University for
  their NEH Humanities Connection Planning grant application entitled "Humanities at the Heart of
  Mission-Centered Interdisciplinary Inquiry: Environmental Studies at Misericordia University"; If funded,
  EPCAMR would support the experiential learning component in the course by working with faculty to
  develop and support site visits to local streams and abandoned mines throughout Northeastern PA
- EPCAMR inquired to Dana Kuhnline-through Appalachian Voices, about putting in another mini-grant to the RECLAIM Field Fund to continue pushing for support through outreach and education to groups on RECLAIM and by assisting them with the production of AML maps for their watersheds or Congressional Districts
- Participated on a PA AML Campaign Conference call and had a separate call with John Walliser-PEC
- Assisted John Levitsky, Luzerne Conservation District Watershed Specialist with preparing some design documentation and paperwork for an Instream Waiver Emergency Permit from the PA Fish & Boat Commission for the Glen Oaks Project in Dennison Township in the Nescopeck Creek watershed

### **Education & Outreach**

- Reviewed and approved the 4' x 2' banner from Center City Print for our joint STEM & AMD Art Exhibit by the Wyoming Seminary Environmental Science Students, The Interdependence Hexagon Project, and EPCAMR; The banner was exhibited at our PA AMR Conference in Pittsburgh; EPCAMR sent Dr. Nerozzi picture within the Solomon Creek watershed in preparation for the upcoming Art Show at the KCC Gallery in Kingston, PA; EPCAMR, the Executive Director, Dr. Andrea Nerozzi, and Wyoming Seminary received the 2019 International Interdependence Hexagon Community Partnership Award; Set up the EPCAMR Exhibit at the KCC Gallery that will run from the opening reception on October 4<sup>th</sup> through November 4<sup>th</sup>, 2019
- Reached out to Patrick Rooney in Congressman Dan Meuser's Office to encourage him to sign on to
  the AML Reauthorization Bill and thanked him for coming up to the AMD/AML Economic Development
  Tour of the Bliss Banks on the Earth Conservancy property with TU, PA DEP BAMR, and other
  regional partners; Dan Meuser and Connor Lamb signed on to the Reauthorization Bill, HR 4248 that
  was recently introduced; The Western Colorado Alliance and Southern Appalachian Mountain
  Stewards both signed on to support Reauthorization; All 49 PA TU Chapters signed on to support
  Reauthorization; Participated in a conference call with members of the PA AML Campaign and Jeremy
  Marcus-Congressman Cartwright's Office to learn more about the Reauthorization Bill;

- Set up the Trout in the Classroom (TIC) Tanks in the Life Skills Classroom and Science Classroom at Greater Nanticoke Elementary with Mike for Mrs. Dennis and Ms. Schraeder's Class; Informed Mr. Ron Kirkutis, Lake-Lehman High School teacher of how to become involved with the TIC program in 2020, since the teacher training program is complete for the 2019-2020 cycle
- Worked with Mike and ARIPPA to educate Congressmen Cartwright's and Meuser's Staff on the
  benefits of a coal refuse energy tax credit program that dedicates some funding to riparian restoration
  of the abandoned mine lands as a part of the reclamation project and removal of the waste culm to
  generate electricity; EPCAMR informed them that we were in agreement with the language and
  supportive of the bill that going forward
- Prepared soundbytes and researched information on AML Statistics to provide to Melvin Felix, who created a press release on Reauthorization for Congressman Cartwright and used a quote from EPCAMR
- Followed up with Greg Malaska-PATU President to continue to keep an open dialogue with Jaret Gibbons from ARIPPA on developing a partnership with them in support of reclamation and watershed restoration efforts across PA
- Met with Liz Fienberg, NFWF about funding future EPCAMR projects and building a stronger partnership with them to secure additional funding for the EPCAMR Region
- Participated in the National RECLAIM Working Group conference call and provided updated on EPCAMR's work to support RECLAIM and assisting several states with producing AML Statistical Maps for their respective Congressional Districts

- EPCAMR signed on to support Congressman Cartwright's coal bonding reform bill that was a part of
  the Energy and Mineral Resources Subcommittee hearing on fiscal reforms; This legislation eliminates
  self-bonding, which is essentially a promise from a coal company to pay for reclamation without
  providing any collateral; It also requires the disclosure of any appraisal or valuation of real property or
  equipment used for bonding purposes, and there's a little section where the Secretary can
  require executive compensation, including salaries and bonuses, as collateral
- EPCAMR signed on to the Choose Clean Water Coalition's sign on letter to support the non-regulatory Chesapeake WILD Act that would direct the US Fish & Wildlife Service to establish a grants program to enhance fish and wildlife and their habitats; Non-profit organizations would be eligible to receive these project grants, and the intent is to help accelerate progress in a few key areas, such as:
  - Riparian buffer restoration
  - Improving stream health
  - Tidal and non-tidal wetland restoration
  - Improving fish habitat
  - Expanding populations of black ducks, and other key waterfowl
  - o Restoring and protection eastern brook trout and their habitat

## **Community Volunteer Coordination**

- Reached out to Pagnotti Enterprises to update them on the coordination of the 6<sup>th</sup> Annual Centralia Cleanup; Pagnotti provided EPCAMR with a \$250 sponsorship for the event and remains supportive of the effort each and every year; Received a \$10 donation from Joanne Russell-United Kingdom
- Picked up the placard listing all sponsors, supporters, and donors for the informational kiosk as an Eagle Scout Project that was constructed by Matthew Williams, his family, the EPCAMR Executive Director, in the Ashley Borough Park where we completed the Dam Removal and Habitat Improvement Project last year
- Mailed Carol Gargan some of EPCAMR's iron oxide pigment for an art project that she would like to do
  in the Kosciouska Healing Garden park in Scranton on some trees creating monarchs on dead trees
  artistically with the pigment
